

TRACT factor	Definition	TRACT questions to consider when assessing Care Trajectory complexity	Suggested score	Rationale
Health Status	Factors relating to an individual's diagnosis and health status that may impact on trajectory management.	How certain is the individual's diagnosis? * Does the individual have more than one health condition? * If the individual has more than one health condition, do they affect each other? * How stable and predictable is the individual's condition? * How familiar is the nursing staff with the individual's health care needs?		
Care Team	Factors relating to the health and social care team that may impact on trajectory management.	How many different health and social care providers are involved in the case? * Are the team familiar with each other? * How easy is it for all team members to communicate and share information and knowledge about the individual? * Is there agreement within the team about care and treatment plans? * Is there agreement between the individual/family and health/social care team about care and treatment plans? * Is there a requirement for case conferences or dedicated multidisciplinary team meetings?		
Social	Factors relating to an individual's social circumstances that may impact on trajectory management.	Does the individual's family/social network have implications for their care trajectory management? * Does the individual have family/social obligations and responsibilities that impact on their care trajectory management? * Do the individual and family agree on their health and social care arrangements? *Are there cultural considerations that impact on individual's health and social care arrangements? * Are their considerations related to the individual's occupation or work that impact on care trajectory management?		
Psychological	Factors relating to an individual's psychological status that may impact on trajectory management.	Is care trajectory management affected by the psychological impact of an illness or injury? * Is care trajectory management affected by the psychological impact of the illness or injury on the individual's family? * Is the illness or injury life changing?

TRACT factor	Definition	TRACT questions to consider when assessing Care Trajectory complexity	Suggested score	Rationale
Cognitive	Factors relating to an individual's cognitive status that may impact on trajectory management.	Does the individual have problems with memory that impact on care trajectory management? * Does the individual have problems with thinking skills that impact on care trajectory management? * Does the individual have a learning disability that impact on care trajectory management?		
Legal	Factors relating to the legal aspects of individual's care that may impact on trajectory management.	Are there safeguarding/guardianship issues involved in the case? * Are there issues relating to decision making and power of attorney in the case?		
Financial	Factors relating to financial aspects of an individual's care that may impact on trajectory management.	Are there issues in relation to the funding of care arrangements that may impact on care trajectory management?		
Resources	Factors relating to the organisation and maintenance of an individual's material resources (equipment and/ or physical aides) that may impact on trajectory management.	Does the individual require equipment and/or physical aides to support their health and social care needs? * Does the ward/unit have in place the equipment and aides required? * Are adaptations and/or modifications to the individual's home required? * Are special arrangements required to support medications management? * Is there a requirement for education and knowledge sharing with non-specialist care providers? * Is there a need for education and knowledge sharing with individuals and/or family?		
Interventions and Procedures	Factors relating to an individual's care and procedures/treatment interventions that impact on care trajectory management?	Is the individual scheduled to undergo any procedures: surgery; diagnostic tests; interventions? * Is the procedure routine for the ward or is it necessary to make specialist arrangements? * How familiar is the nursing staff with the requirements for these procedures?		
Transfers of Care	Factors relating to the information requirements of admission, discharge and transfers of care which may have an impact on trajectory management.	Has the individual been transferred from another department/ ward/hospital? * Does the plan of care involve transfers of care? * Are the arrangements for discharge complex? * How familiar is the unit with the organisations involved in transfers of care?
